ADMISSIONS and ENROLLMENT STATEMENT
DEFINITION OF “HIGH RISK” STUDENT

After completion of this application packet, and a successful interview with a Counselor and/or administrator, each student applicant will be placed on the waiting pool. Endeavor Academy will admit students on a “first come – first served” basis, and highest priority will be given to seniors and juniors. Older students will sometimes be placed at the top of the list to ensure graduation by 21 years of age.

Endeavor Academy will give highest priority to students who meet the Colorado Department of Education’s definition of a “high risk” student. A “high risk” student is defined as a student enrolled in a public school who: (please check **all** that apply to you)

- Has an IEP.*
- Has been committed to the Department of Human Services following adjudication as a juvenile delinquent or is in detention awaiting disposition of charges that may result in commitment to the Department of Human Services.*
- Has dropped out of school or four excused or unexcused absences from public school in any one month or ten excused or unexcused absences from public school during any school year. Absences due to suspension or expulsion of a student are considered absences for purposes of this paragraph.*
- Has been expelled from school or engaged in behavior that would justify expulsion.*
- Is a migrant child, as defined in § 22-23-103 (2), C.R.S.*
- Is a homeless child, as defined in § 22-1-102.5 (2), C.R.S.*
- Is over traditional school age for his/her grade level **OR** lacks adequate credit hours for his/her grade level.*
- Has a documented history of personal drug or alcohol use or has a parent or guardian with a documented dependence on drugs or alcohol.
- Has a documented history of personal street gang involvement or has an immediate family member with a documented history of street gang involvement.
- Has a documented history of mental or behavioral health issue or has experienced significant trauma.
- Has a documented history of repeated school suspensions.
- Has a documented history of child abuse or neglect, has been adjudicated a ward of the court or has been involved in the foster care system.
- Has a parent or guardian in prison or on parole or probation or has experienced the loss of a parent or sibling.
- Has a documented history of domestic violence in the immediate family.
- Is a parent or pregnant woman under the age of twenty years.
